

**RESOLUTION NO. 09-16**

**A RESOLUTION OF THE CITY OF LAKE ALFRED, FLORIDA;  
GRANTING AUTHORITY TO THE FINANCE DEPARTMENT TO  
WRITE OFF BAD UTILITY DEBTS FOR FISCAL YEAR  
2015/2016 FOR AUDITING PURPOSES; PROVIDING FOR AN  
EFFECTIVE DATE.**

**WHEREAS**, the City of Lake Alfred is required, by financial procedures, to write off all bad utility debts for auditing purposes; and

**WHEREAS**, debt in the amount of \$12,627.02 is to be written off for the fiscal year of 2015/2016; and

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Lake Alfred, Florida, as follows:

**SECTION 1. AUTHORIZATION.**

That the City Commission authorizes the Finance Department to write off all bad utility debts for the fiscal year 2015/2016 as more specifically identified herein, for audit purposes.

**SECTION 2. ACCOUNT INFORMATION.**

The Utility Debt Write-Off Accounts of the City of Lake Alfred for the fiscal year 2015/2016 is represented in Exhibit "A" and is attached hereto and incorporated and made a part of this Resolution.

**SECTION 3. EFFECTIVE DATE.**

This Resolution shall take effect immediately upon passage and adoption by the City Commission.
