AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF LAKE ALFRED, FLORIDA, AMENDING THE FUTURE LAND USE MAP OF THE 2030 COMPREHENSIVE PLAN OF THE CITY OF LAKE ALFRED, FLORIDA, BY ASSIGNING THE MIXED-USE (MU) FUTURE LAND USE DESIGNATION ON APPROXIMATELY 1.97± ACRES OF LAND; GENERALLY LOCATED AT 0 LAKE ALFRED ROAD, FURTHER DESCRIBED AT THE NORTHEAST CORNER OF THE INTERSECTION OF LAKE ALFRED RD AND ADAMS BARN RD, NORTH OF LYNCHBURG RD. INCLUDING PARCEL: 262731-000000-044050; TRANSMITTING SAID AMENDMENT TO THE DEPARTMENT OF ECONOMIC OPPORTUNITY; REPEALING ALL ORDINANCES IN CONFLICT HERewith; PROVIDING FOR SEVERABILITY; PROVIDING FOR THE ADMINISTRATIVE CORRECTION OF SCRIVENER'S ERRORS AND CODIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE.

This Business Impact Estimate is provided in accordance with section 166.041(4), Florida Statutes.
